JULY AUTOTEST 30th July 2017

1. The Stonehaven & District Motor Club Limited will organise a **Clubman Autotest** and **Clubman Production Car Autotest** on Sunday 30th July 2017 at Coneyhatch Farm, Stonehaven. OS Map Reference 45 / 870894. The event will be promoted by the North East of Scotland Motorsports Club and will take place on a sealed surface.
2. The meeting will be held under the General Regulations of the RACMSA Ltd incorporating the provisions of the International Code of the FIA, these supplementary regulations, and any written instruction the organising club may issue.

4. The event is open to all fully paid up members of organising club and the following invited Clubs:-

5. Entrants must produce a valid club membership card of one of the invited clubs.
6. The event is a round of the 2017 SDMC and North East of Scotland Motorsport's Club Championships.
7. The programme of the meeting shall be:-

Paddock Opens 10.00hrs
Scrutineering 10.30hrs
First Car Starts 11.00hrs

NB: Any competitor not signed in by 1100hrs may be excluded.
8. The Clubman Autotest will consist of 4 classes as follows:-

Class 1 Specials & Kit Cars
Class 2 All other vehicles up to 1400cc
Class 3 All other vehicles 1401 and over
Class 4 Cars to SDMC "Fiesta Class" regulations

The Clubman Production Car Autotest will consist of 1 class as follows:-

Class 5 Production cars all capacities (as per M18.1)
9. All vehicles must comply with RAC MSA Technical Regulations.
10. The event will take place wholly on private property and vehicles do not require to be road taxed.
11. Vehicles may be entered by up to 3 different drivers.
12. Awards will be presented as follows: Fastest time of the day in each event- perpetual award.

13. Individual class awards may be presented depending on number of competitors. Awards will be presented at the annual SDMC Dinner & Awards in January 2018.
14. The entry list opens on receipt of these regulations and closes at 2200hrs on Wednesday 26th July 2017. The entry fee is £10.00. All entries must be made on the official entry form and accompanied by the appropriate fee. Cheques should be made payable to Stonehaven & District Motor Club.

The maximum entry for the meeting is 30 and the minimum is 12. The minimum for each class is 4. Should either of the above minimum figures not be reached, the organisers have the right to either cancel the meeting or amalgamate classes as necessary.

Entry fees will be refunded if event is cancelled. There may be a small refund penalty for payments received via PayPal.

18. Any protests must be lodged as per C5.
19. Details of the tests will be available at signing on.
20. Each driver will have two runs at each test with the best result to count.
21. Timing will be by hand held watch.
22. The starting signal will be 3, 2, 1, Go.
23. The order of attempting tests will be in class order.
24. Practising will not be allowed.
25. Competitors will be identified by numbers which will be provided by the organisers.
26. Marking and penalties will be as printed in the appropriate section of the RAC MSA General Regulations.
27. Course markers may be less than 1m in height.
28. Anyone practising or travelling at excessive speed out with the specified course will be automatically excluded.
29. **Access to the venue is by permission of the landowner, please obey the speed limit signs and be considerate to other users of the farm buildings. We depend on this venue, please do not give the landowner any reason to withdraw his permission.**
